

The Program was attended by 27 students, 10 students from Universitá Politecnica delle Marche (Italy), 4 from Karlsruhe University of Applied Sciences (Germany), 5 from the Kaiserslautern University of Applied Sciences (Germany) and 8 students from the School of Economics of the Universidad Nacional del Litoral (Argentina).



#### **WELCOME ACTIVITIES**

On 28th August, the Dean of the School of Economics, the rest of authorities and the advisors of the program give a welcoming reception to the participants. The authorities emphasized the importance of this program for the internationalization process of the participating universities. After this meeting, the company assignments were presented to each group which prepared the encounters with the companies' owners or management that were held during the afternoon.

This program gives the students the opportunity to get in contact with real companies in Argentina presenting real problems they face. It is a challenging experience where not only attendants put in practice the knowledge they got at regular courses but most importantly, offers the opportunity to communicate, work and share with colleagues from other parts of the world, working together in a consultancy-like experience.





# **VISITING THE COMPANIES**

The students were divided into 5 groups according to their backgrounds to work on the consultancy assignments given by local companies. On the first day of the program they visited the following companies: Moka (Santa Fe), Insuga (Recreo, Santa Fe), CoSar (Sauce Viejo, Santa Fe), Ivopé (San Jerónimo Norte, Santa Fe).







#### **WORKING DAYS**

The following days, all the groups started to work very intensively on the tasks during the mornings, and in the afternoons, they had daily meetings with the International Board of Advisors, where they showed their progress and got international guidance.





## **LEISURE ACTIVITIES**

Besides the academic activities, students and professors spend some time out with their colleagues getting the most out of the Argentinean culture. Walks, clubbing and outdoors activities were organized setting a real friendly environment, visit to the brewery of the city.







## **FINAL PRESENTATIONS**

On Friday 8th September, each group gave the final presentations to the representatives of each participating company at School of Economics. These meetings were based on the final reports, previously assessed by the Board of Advisors. In this way, companies received suggestions from qualified consultants and students had the opportunity to work in a real case, with the support of international advisors.
